### **HRSA Nurse Faculty Loan Program (NFLP) (Application Deadline: February 3, 2020)**

The purpose of this program is to increase the number of qualified nursing faculty by supporting schools of nursing to establish and operate a student loan fund in accordance with the terms outlined in the authorizing statute. Recipient institutions shall make loans to individuals consistent with that purpose, and an amount up to 85 percent of any such loan (plus interest thereon) shall be canceled by the school, according to the schedule prescribed in statute, upon completion of up to four years of full-time employment as a nurse faculty member in an accredited school of nursing. The purpose of this program is to provide educators across the nation the opportunity to broaden and deepen their engagement with the humanities. The purpose of the K-12 Educators component is to provide school teachers across the nation the opportunity to broaden and deepen their engagement with the humanities. Funding will support one- to four-week residential programs, led by scholars and K-12 professionals, that allow participants to study a variety of humanities topics. **USDA Organic Transitions (ORG)  
(Application Deadline: February 27, 2020)**

The overall goal of the Organic Transitions Program (ORG) is to support the development and implementation of research, extension and higher education programs to improve the competitiveness of organic livestock and crop producers, as well as those who are adopting organic practices. NIFA administers the ORG program by determining priorities in U.S. agriculture through Agency stakeholder input processes in consultation with the NAREEEAB. ORG will continue to prioritize environmental services provided by organic farming systems in the area of soil conservation, pollinator health, and climate change mitigation, including greenhouse gases (GHG), as well as the development of educational tools for Cooperative Extension personnel and other agricultural professionals who advise producers on organic practices, and development of cultural practices and other allowable alternatives to substances recommended for removal from the National Organic Program's National List of Allowed and Prohibited Substances. It is expected that all projects will integrate research, education and extension activities, as appropriate to project goals, although some projects may be weighted more heavily than others in one or more of these areas. **ARC POWER (Partnerships for Opportunity and  
Workforce and Economic Revitalization) Initiative  
(LOI Deadline: February 28, 2020)**

The purpose of this program is to help communities and regions that have been affected by job losses in coal mining, coal power plant operations, and coal-related supply chain industries due to the changing economics of America's energy production and the coal economy. Funding will support efforts to create a more vibrant economic future for coal-impacted communities by cultivating economic diversity, enhancing job training and reemployment opportunities, creating jobs in existing or new industries, and attracting new sources of investment.

The program seeks to align and leverage complementary federal, state, and other economic development resources that provide assistance through competitive awards to partnerships anchored in coal-impacted communities. By aligning and leveraging multiple resources, the program prioritizes the selection of projects that integrate multiple economic development systems and resources in support of implementing existing economic development strategic plans.

For coal-impacted communities to diversify their local and regional economies successfully, the program prioritizes projects and activities that: 1) Produce multiple economic development outcomes; 2) Are specifically identified under state, local, and/or regional economic development plans; and 3) Have been collaboratively designed by diverse state, local, and regional stakeholders.

Projects must address at least one of the following goals: 1) Economic opportunities: invest in entrepreneurial and business development strategies that strengthen Appalachia's economy; 2) Ready workforce: improve the education, knowledge, skills, and health of residents to work and succeed in Appalachia; 3) Critical infrastructure: invest in critical infrastructure, especially broadband; transportation, including the Appalachian Development Highway System; and

water/wastewater systems; 4) Natural and cultural assets: strengthen Appalachia's community and economic development potential by leveraging the region's natural and cultural heritage assets; and 5) Leadership and community capacity: build the capacity and skills of current and next-generation leaders and organizations to innovate, collaborate, and advance community and economic development. The program focuses on investments that are regional, strategic, and transformational, and that maximize the economic revitalization of coal-impacted communities and regions. It is strongly encouraged that projects have a regional and/or multistate focus supported by state and local planning, be large in scale, and be targeted to economic restructuring. [LEARN MORE](#)

### **HRSA Scholarships for Disadvantaged Students (Application Deadline: March 3, 2020)**

The SDS Program increases diversity in the health professions and nursing workforce by providing awards to schools of medicine, osteopathic medicine, dentistry, nursing, pharmacy, podiatric medicine, optometry, veterinary medicine, public health, chiropractic, allied health, graduate programs in behavioral and mental health practice, and physician assistant programs, to provide eligible health profession schools for scholarships to students from disadvantaged backgrounds who have financial need, including students who are members of racial and ethnic minority groups. The SDS Program aims to enroll and retain full-time students from disadvantaged backgrounds, including students who are members of racial and ethnic minority groups. ### **HRSA Nurse Anesthetist Traineeship (NAT) Program (Application Deadline: March 6, 2020)**

The purpose of this program is to support eligible entities to meet the cost of traineeships for individuals (full-time only) in nurse anesthesia degree programs. Grants are awarded to accredited institutions that educate registered nurses to become nurse anesthetists; recipient institutions, in turn, disburse funds to students in the form of traineeship support. The aim is to increase the number of Certified Registered Nurse Anesthetists nationally who are well prepared and well-positioned to practice independently and deliver evidence-based, high quality, and safe anesthesia and services related to the management and treatment of acute and chronic pain. NAT students may use traineeship funds during the period for which the traineeship is provided for full or partial costs of the tuition and fees, books/e-books, and reasonable living expenses (stipends). The funds appropriated for the NAT Program are distributed among all eligible applicant institutions based on a formula. [LEARN MORE](#)

### **DHHS Community Rehabilitation Program (CRP)** **(Application Deadline: Rolling)**

The purpose of this program is to provide assessment, training, and appropriate supports for consumers with disabilities to reach successful competitive employment. Quality services in the areas of supported employment and work adjustment services must be provided by successful applicants. This program offers facility-based and community-based services that are designed to provide consumers with disabilities with equal opportunities in achieving their highest level of economic and social independence. Supported service models include: 1) Supported employment (SE): requires long-term vocational support and may include job development, job placement, intensive job coaching, and community-based supplemental evaluation to determine required supports and vocational direction; 2) Project Search: includes transition training and placement services for students with disabilities who have significant intellectual or developmental disabilities; and 3) Work adjustment services (WA): includes job development, placement, and coaching, as well as activities to improve and increase productivity, attendance, punctuality, ability to work with others, work tolerance, and ability to work under supervision. Survivors from underserved populations face challenges in accessing comprehensive and effective victim services that fully meet their needs. As a result, survivors of these crimes from underserved communities often do not receive appropriate services. The Underserved Program supports projects to bridge these gaps. The purpose of all grants made by the Underserved Program is to provide or enhance population specific outreach and services to adult and youth victims in one or more underserved populations. of human trafficking and any dependents to: 1) Locate and secure permanent housing; 2) Secure employment, including obtaining employment counseling, occupational training, job retention counseling, and counseling concerning reentry into the workforce; and 3) Integrate into a community by providing victims and dependents with services, such as transportation, counseling, child care services, case management, and other assistance Applicants may provide legal services, the purchase/lease of vehicles, and services for children in limited circumstances.

The program seeks to align and leverage complementary federal, state, and other economic development resources that provide assistance through competitive awards to partnerships anchored in coal-impacted communities. By aligning and leveraging multiple resources, the program prioritizes the selection of projects that integrate multiple economic development systems and resources in support of implementing existing economic development strategic plans.

For coal-impacted communities to diversify their local and regional economies successfully, the program prioritizes projects and activities that: 1) Produce multiple economic development outcomes; 2) Are specifically identified under state, local, and/or regional economic development plans; and 3) Have been collaboratively designed by diverse state, local, and regional stakeholders. Projects must address at least one of the following goals: 1) Economic opportunities: invest in entrepreneurial and business development strategies that strengthen Appalachia's economy; 2) Ready workforce: improve the education, knowledge, skills, and health of residents to work and succeed in Appalachia; 3) Critical infrastructure: invest in critical infrastructure, especially broadband; transportation, including the Appalachian Development Highway System; and water/wastewater systems; 4) Natural and cultural assets: strengthen Appalachia's community and economic development potential by leveraging the region's natural and cultural heritage assets; and 5) Leadership and community capacity: build the capacity and skills of current and next-generation leaders and organizations to innovate, collaborate, and advance community and economic development. The program focuses on investments that are regional, strategic, and transformational, and that maximize the economic revitalization of coal-impacted communities and regions. ## Forecasted Federal Grants

**NCDHHS Local Justice Systems to Combat Opioid Epidemic  
(Estimated Application Deadline: TBD)**

The Bureau of Justice Assistance's Comprehensive Opioid Abuse Program (COAP) Statewide Implementation, Enhancement and Evaluation Initiatives has awarded the NC Department of Health and Human Services (NCDHHS) a three-year, \$6.5 million grant.

As part of this federal grant, NCDHHS will release a Request For Applications (RFA) to competitively award funds to applicant sites for: 1) Pre-arrest or pre-conviction diversion programs, such as Law Enforcement Assisted Diversion (LEAD Programs) and Police Assisted Addiction and Recovery Initiatives (PAARI), that divert low-level offenders to appropriate treatment options; 2) Comprehensive jail-based medication assisted treatment programs that provide medication assisted treatment (MAT) to individuals during incarceration and connect them to continued treatment upon release. Comprehensive MAT programs – which include providing buprenorphine, methadone or both – along with group and/or individual therapy services are the gold standard for opioid use disorder treatment; and 3) Overdose prevention education and naloxone distribution programs to engage people during incarceration and provide harm reduction education on how to prevent overdoses, respond to an overdose, and access community resources.

Sites may apply to implement a program that includes one, two or all three of these strategies.
