## HRSA COVID-19 Claims Reimbursement for Uninsured Patients (Application Deadline: Rolling)

HRSA provides an electronic reimbursement portal for healthcare providers who have conducted COVID-19 testing or provided treatment for uninsured individuals on or after February 4, 2020. Reimbursement will be made for qualifying testing and treatment services, which include: Specimen collection, diagnostic, and antibody testing; Testing-related visits in the office, urgent care, emergency room, or telehealth; Treatment including office visits, telehealth, emergency room, inpatient, outpatient/observation, skilled nursing facility, long-term acute care, acute inpatient rehab, home health, emergency ground ambulance transportation, non-emergent patient transfers via ground ambulance, and FDA approved drugs as they become available for COVID-19 treatment and administered as part of an inpatient stay; When an FDA-approved vaccine becomes available, it will also be covered. Additionally, the BHWET Program for Professionals emphasizes interdisciplinary collaboration by utilizing team-based care in integrated behavioral health and primary care settings and recruiting a workforce that reflects participation in the institutions' programs of individuals and groups from different racial, ethnic, cultural, geographic, religious, linguistic, and class backgrounds, and different genders and sexual orientations, interested in serving high need and high demand areas. ### HRSA Regional Telehealth Resource Center Program (Application Deadline: January 21, 2021)

The purpose of the RTRC Program is to provide expert and customized telehealth technical assistance across the country. ## CMS Community Health Access and Rural Transformation (CHART) (Application Deadline: February 16, 2021)

The Community Health Access and Rural Transformation (CHART) Model is a voluntary payment model designed to meet the unique needs of rural communities. The CHART Model will test whether aligned financial incentives, increased operational flexibility, and robust technical support promote rural health care providers' capacity to implement effective health care delivery system redesign on a broad scale. The Center for Medicare & Medicaid Innovation (CMMI) will evaluate the impact of the CHART Model on Medicare and Medicaid expenditures, access to care, quality of care, and health outcomes for rural residents. CHART aligns with CMS's Rethinking Rural Health initiative, which aims to ensure individuals in rural America have access to high quality, affordable health care by offering new and creative payment models. The CHART Model will include two tracks: 1) the Community Transformation Track and 2) the Accountable Care Organization (ACO) Transformation Track. This Notice of Funding Opportunity (NOFO) is for the Community Transformation Track only. Under the Community Transformation Track, award recipients will receive cooperative agreement funding and a programmatic framework to assess the needs of their Community (as defined in section A.4.3.1. Community Definition below) and implement health care delivery system redesign. Hospitals participating in the Community Transformation Track Alternative Payment Model (APM) will receive capitated payments. Capitated payments provide hospitals with a stable revenue stream and incentivize reductions in fixed costs and avoidable utilization. Operational flexibilities will be available for participating hospitals to relieve regulatory burden, emphasize high-value services, and support providers in care management for their beneficiaries. ### USDA Economic Impact Initiative Grants (Application Deadline: Rolling)

Economic Impact Initiative Grants provide funding to assist in the development of essential community facilities in rural communities that have extreme unemployment and severe economic depression. An essential community facility is one that provides an essential service to the local community, is needed for the orderly development of the community, serves a primarily rural area, and does not include private, commercial, or business undertakings. ## NCDHHS North Carolina School Health Center Program (Application Deadline: December 31, 2021)

The purpose of the North Carolina School Health Centers Program is to provide funding to School Health Centers (SHCs) that will enable them to increase access to age-appropriate health care for older children and adolescents, ages 10 to 19, with the goals of improving the health status and supporting the academic achievement of young people who live in underserved communities with increased risks due to social and economic factors. SHCs funded through this RFA shall be required to provide access to comprehensive, coordinated and preventive health care either through services and programs and/or referrals to other primary care providers, medical specialists, mental and behavioral health agencies, nutritionists and other community services and programs. Through direct services and/or referral networks, SHCs shall be required to focus on early intervention and prevention by assuring access to annual age-appropriate wellness visits (Health Check/EPSDT), health risk assessments and immunizations. The applicants that are selected through this RFA must provide evidence that they have the capacity to implement quality services that are sustainable and are in compliance with the North Carolina Quality Assurance Standards for SHCs and Performance Measures for SHCs based on Bright Futures guidelines and other national guidelines and recommendations. ## NCDHHS Rural Health Center Capital Grant SFY 2020-2021 (Application Deadline: January 8, 2021)

The purpose of grants awarded under this program is to support State-Designated Rural Health Centers. ORH assists underserved communities and populations with developing innovative strategies for improving access, quality, and cost-effectiveness of health care. The ability of a healthcare facility to meet the needs of a rural patient population is directly related to the efficiency, size, and quality of the facility and its equipment. Capital Grant funding allows for investment in healthcare infrastructure, including the construction, renovation, and expansion of rural healthcare facilities. Capital investments can also be made through the purchase and installation of major equipment and technology. ## The Burroughs Wellcome Fund Next Gen Pregnancy Initiative (Application Deadline: December 1, 2020)

Building upon the original goals of the BWF Preterm Birth Initiative, a recently convened Pregnancy Think Tank has helped shape the next generation of BWF preterm birth awards. Growing evidence suggests the interrelatedness of the duration of pregnancy, fetal growth, and adverse pregnancy outcomes such as preterm birth, preeclampsia, intrauterine growth restriction, stillbirth, and maternal medical complications including maternal mortality. Other areas of interest are climate change and environmental impact on pregnancy, complications associated with ART, and epigenome-wide association studies. We seek to expand the scope of this award mechanism to capture these and other pregnancy outcomes as we believe they will be mutually informative and accelerate discovery.
