

## Situation

In March of 2023, Pactiv Evergreen Inc. announced the closure of its Canton Paper Mill in Haywood County, North Carolina. According to the announcement, the permanent closure would result in the loss of 900 jobs at the mill beginning around June 9, 2023.<sup>1</sup>



The mill, having begun operations in 1908, sits on 185 acres within the Town of Canton. Primary operations at the mill are manufacturing paper from pulp, which also includes the conversion of the paper made there.

## Explanation of the Analysis

### Purpose

The purpose of the analysis is to gain a greater understanding of how the Mill's closing will affect the eighteen-county Western North Carolina economy. The results should provide residents and policy-makers an unbiased and quantifiable account of what to expect as the Mill's operations come to an end. Using industry-accepted methods, the analysis first objectively quantifies and tracks local spending that originates from the Mill's activities; and then follows that spending as it moves through the local economy. Removing those spending flows and identifying what is lost or at-risk of being lost provides the basis of the results. The final outcomes are presented as negatives, indicating the expected reductions in demand due to the Mill's closing.

## Key Terms

Throughout the analysis there are several repeated terms which are important to understand:

- **Mill** Referencing the initial closing of the Canton Paper Mill's operation, including the layoff of 900 workers. In economic modeling this is referred to as the *direct* impact.
- **Local Suppliers** Western North Carolina region businesses that supply the Mill with the goods and services needed for the Mill to operate. In economic modeling this is referred to as *indirect* impacts.
- **Local Household Spending** The spending by Western North Carolina region workers and business owners employed by the Mill or by local suppliers in the region. In economic modeling this is referred to as *induced* impacts.
- **Lost** The confirmed final impacts from the Mill's closure.
- **At-Risk** Western North Carolina region businesses and workers that will experience reductions in demand for their goods and services on account of the Mill's closure. For some this may lead to closings or layoffs, while others may be able to redirect their offerings or adapt to the change in other ways.

## Limitations

All results should be treated as estimates, as there is no proven way to completely capture the complexities of a dynamic economy. In reality, jobs, businesses, products and policies are constantly changing. The analysis *freezes* the Western North Carolina region economy at a point in time and then carefully measures the expected interactions between local participants but recognizes that over time these relationships change and adapt.


The analysis examines only the impact of the Mill's closure. The Mill's multi-generational presence in Canton includes deep integration throughout the local economy beyond the Mill's primary operation. The future of the shared wastewater treatment system, the Waynesville plant, and ownership of multiple outlying properties are a few of the peripheral entanglements not included in the analysis.

Economic impact analyses use *spending* as the primary factor to capture the effects of an economic change in activity. Spending presents a quantifiable variable from which an analyst can reliably model and track where and how dollars will flow in a particular situation. While spending is an important element, it fails to capture broader social and cultural impacts. The analysis does not address the Mill closing’s deeper social and cultural impacts on the community nor the personal impacts on its workers and their families.

## Methodology

To measure economic impacts the IMPLAN® economic modeling system<sup>2</sup> was employed. IMPLAN® is an input-output model that is comprised of software and regional data sets. IMPLAN® is an acronym for IMPact analysis for PLANning. The IMPLAN® model was originally developed by the USDA Forest Service in cooperation with the Federal Emergency Management Agency (FEMA) and the USDI Bureau of Land Management to assist in resource management and planning. Currently the model is used by hundreds of public, private, and academic organizations.

The overriding objective of the model is to measure the full economic impact to a local economy as the result of a specific economic activity. The model is built upon a matrix detailing the input-output relationships among industries and consumers. The primary matrix structure is derived from the National Bureau of Economic Analysis’s Benchmark Input-Output Model. The national model was realigned to match the Western North Carolina region economy. Output ratios and imports for over 546 industrial sectors in the area are assigned. Purchase coefficients are derived to measure the percentage of intermediate and final demands that are satisfied from local production and the percentage that are imported from outside the area. Consumer expenditure patterns, price deflators, industry employment levels, household income groups and the area population are also factored in for the local economy. Supplier information from an online survey, hosted by the Haywood County Chamber of Commerce, was used to confirm and augment details on specific suppliers and their offerings to the Mill.

# Key Findings

## *Employment Impacts*

- The Mill's closure, resulting in the direct loss of 900 jobs, will impact another 1,622 jobs in the Western North Carolina region. A total of 2,522 jobs in the region will be lost or at-risk of being lost.
- For every job lost at the Mill, another 1.8 jobs in the region will be put at-risk.
- Of the impacted jobs, 1,055 will be from regional suppliers which provide goods and services directly to the Mill. Another 566 regional jobs will be impacted due to the expected reduction in spending by local households from workers at the Mill and its suppliers.
- Among Western North Carolina counties, Haywood County is expected to suffer the bulk of worker impacts from the Mill's closing. In total, Haywood County has 1,883 jobs lost or at risk: nearly 75 percent of the total impacted jobs.
- Buncombe County is the second most impacted Western North Carolina county with an expected impact of 193 jobs being put at-risk. Rutherford follows closely as the third most impacted regional county with 158 jobs at-risk.
- Among jobs put at-risk in the Western North Carolina Region, the *Forestry & Sawmills* industrial grouping is expected to suffer the deepest impacts, totaling 325 jobs. *Forestry & Sawmills* is the most impacted industry in eleven of Western North Carolina's eighteen counties.

## *Labor Income Impacts*

- The Mill's closure will cause a direct loss of \$87.2 million of labor income and put at-risk another \$78 million from affected industries, resulting in a total of \$165.2 million of labor income in jeopardy in the Western North Carolina region.
- Impacts to local suppliers results in \$54.4 million of labor income placed at-risk, while reduced household spending places another \$23.6 million at-risk.
- Every dollar of labor income lost with the Mill's closing places another \$0.90 worth of income at-risk in the Western North Carolina region.

## *Output Impacts*


- The Mill's closure will cause a direct loss of \$615.8 million in output and put at-risk another \$317.4 million of output from affected industries, resulting in a total of \$933.2 million of output in jeopardy in the Western North Carolina region.
- Local suppliers will see \$237 million in output at-risk, while local household spending may experience a decline of \$80.5 million.
- Every dollar of output lost with the Mill's closing places another \$0.52 worth of output at-risk in the Western North Carolina region.

## *Tax Impacts*

- Of the grand total of \$58 million of tax revenues placed at-risk in the Western North Carolina region on account of the Mill's closing:
  - County tax collections account for \$7 million or 12.2 percent of the total
  - State tax collections for \$13.3 million or 23 percent and
  - Federal tax collections for \$37.6 million or the remaining 65%.

# Employment Impacts

The Mill’s closure, resulting in the direct loss of 900 jobs, will impact another 1,622 jobs in the Western North Carolina region. A total of 2,522 jobs in the region will be lost or at-risk of being lost. For every job lost at the Mill, another 1.8 jobs in the region will be put at-risk. Of the impacted jobs, 1,055 will be from regional suppliers which provide goods and services directly to the Mill. Another 566 regional jobs will be impacted due to the expected reduction in spending by local households from workers at the Mill and its suppliers.



Among WNC counties, Haywood County is expected to suffer the bulk of worker impacts from the Mill’s closing. Beyond losses at the Mill, local suppliers are expected to experience reductions in demand for their services and products which will put 606 jobs at-risk. Finally, the resulting reduced household spending from Mill and supplier workers will place another 377 at-risk. In total, Haywood County has 1,883 jobs lost or at risk: nearly 75 percent of the total impacted jobs.



Buncombe is the second most impacted WNC county with an expected impact of 193 jobs being put at-risk. Rutherford follows closely as the third most impacted WNC county with 158 jobs at-risk. Five WNC counties have minimal expected job impacts, with less than ten jobs being put at-risk (see table next page for details).



## Impacts by Industry

### Total Jobs At-Risk in the Western North Carolina Region by Industry



Jobs at-risk include impacts on local suppliers and those due to an expected decrease in local household spending from workers.

Among jobs put at-risk in the Western North Carolina Region, the *Forestry & Sawmills* industrial grouping is expected to suffer the deepest impacts, totaling 325 jobs. The *Forestry & Sawmills* sector is of particular interest due to its historic role in the Mill’s location and significance as a primary production input. The sector includes *commercial logging, support for forestry, timber tract production, and sawmills*. Traditionally, *sawmills* fall into the *Manufacturing* industrial classification, but due to their close relationship with *forestry* activities and position with Mill operations they were included in the group.

Haywood County has the most impacted jobs in *Forestry & Sawmills* at 140 or 43 percent of the total. Rutherford County is the second most impacted with an expected 101 positions placed at-risk. *Forestry & Sawmills* is the most impacted industry in eleven of Western North Carolina's eighteen counties.

With an expected 176 jobs placed at-risk, the *Administrative & Support Services* industry is a broad group of local businesses which supply services to buildings and facilities, including office support, maintenance, waste-management, grounds, and security services. The industry is the most impacted in Buncombe County.

The third most impacted industry, with 141 jobs put at-risk, is *Transportation & Warehousing*, primarily impacted by expected losses in demand for trucking and rail transportation operations.

The *Wholesale Trade* industry with 134 jobs at-risk, are businesses which support the Mill operations with machinery, equipment, supplies, and other durable goods.

Several significantly impacted industries have little or no direct link to the Mill but are expected to suffer from the loss of local household spending from workers at the Mill and affected suppliers. These include *Retail Trade*, with 129 jobs at-risk and *Accommodations & Food Services* with 110 positions at-risk. The *Other Personal Services* industry, with 105 jobs at-risk, includes household goods repair & maintenance, dry-cleaning & laundry services, religious & church groups, and barber & beauty shops (see table next page for details).


# Labor Income Impacts

Labor Income is the total of Employee Compensation (wages, salaries, and benefits) and Proprietor Income.

The Mill’s closure will cause a direct loss of \$87.2 million of labor income and put at-risk another \$78 million from affected industries, resulting in a total of \$165.2 million of labor income in jeopardy in the region. Impacts to local suppliers results in \$54.4 million of labor income placed at-risk, while reduced household spending places another \$23.6 million at-risk (see table next page for details).

Every dollar of labor income lost with the Mill’s closing places another \$0.90 worth of income at-risk in the Western North Carolina region.

Haywood County accounts for \$134.2 million of impacted labor income; 81.2 percent of the total impacts in Western North Carolina. Buncombe County’s labor income is the second most impacted; \$10.1 million at-risk or 6.1 percent of the total.


# Output Impacts

Output equals the value of Industry production, which is equivalent to sales plus any change in net inventory. In simpler terms, output is the dollar value of what is produced.

The Mill’s closure will cause a direct loss of \$615.8 million in output and put at-risk another \$317.4 million of output from affected industries, resulting in a total of \$933.2 million of output in jeopardy in the Western North Carolina region. Local suppliers will see \$237 million in output at-risk, while local household spending may experience a decline of \$80.5 million (see table next page for details).

Every dollar of output lost with the Mill’s closing places another \$0.52 worth of output at-risk in the Western North Carolina region.

Haywood County accounts for \$803.6 million of impacted output; 86.1 percent of the total impacts in Western North Carolina. Rutherford County’s output is the second most impacted; \$38.7 million at-risk or 4.2 percent of the total.



# Tax Impacts

An important consideration should be made when viewing these results. **The tax impact results present the improbable, worst-case scenario of the complete absence of a tax-paying entity at the Mill’s location.** While these results reflect a total loss of property tax revenues, the site’s land and building values will instead likely decline over time, while property taxes will still be collected, just at lower values unknown today.

Of the grand total of \$58 million of tax revenues placed at-risk in the Western North Carolina region on account of the Mill’s closing, County tax collections account for \$7 million or 12.2 percent of the total, the State for \$13.3 million or 23 percent and Federal collections for \$37.6 million or the remaining 65%.

Among major County, State and Federal revenue sources<sup>3</sup> the Mill’s closure will place an initial \$28.5 million of tax collections at-risk. Together, the Mill’s initial closing and resulting impacts to local suppliers plus reduced household spending will place a total of \$47.5 million in Haywood County’s tax collections at-risk; equating to 81.8 percent of the total impact in the Western North Carolina region (see table next page for details).

## County Impact Profiles

Following are tables summarizing impacts for each of the eighteen Western North Carolina counties. Each is presented in their rank of employment impacts; highest to lowest.

The profiles reveal the diversity of economic connections among the region's counties and their unique economic specializations. For example, the *Forestry & Sawmills* industry was the top impacted sector in eleven counties, while *Manufacturing* was the top in four, and *Administrative & Support Services*, *Mining* and *Government* were each the top impacted industry in a single county.

## Haywood County

Haywood County, home to the Canton Mill, accounts for the majority of impacts; 75 percent of impacted jobs, 81 percent of impacted labor income, 86 percent of impacted output, and 82 percent of total tax impacts. Beyond the direct 900 manufacturing jobs lost at the Mill, the industry with the greatest number of positions placed at-risk is *Forestry & Sawmills* with an expected impact of 140.4 jobs and reduced output of \$24.7 million. *Administrative & Support Services, Transportation & Warehousing, and Wholesale Trade* are each expected to experience impacts of over 100 jobs.

## Buncombe County

Buncombe is the second most impacted county with 193.1 jobs put at-risk. Buncombe is the only county with impacts from *Reduced Household Spending* (-106.9 jobs or 55%) outpacing impacts from *Local Suppliers* (-86.2 jobs or 45%). This is due to the expected reduction in demand for services from workers at the Mill and workers at impacted local suppliers, as seen in *Health Care & Social Assistance* (-25.1 jobs) and *Retail Trade* (-20.2 jobs). Overall, the most impacted industry is *Administrative & Support Services* (-28.5 jobs).

The IMPLAN model does not provide a clear description of the *Government* services supplied to the Mill which will be put at-risk. With timber as a critical input to the Mill and the significance of public lands in the county the *Government* services may be involved in forestry management.
